Rental Agreement

1. We do not allow the drugs or alcohol on the premises at any time.
2. All groups must comply with the Colorado State requirements and regulations. A copy will be sent upon request.
3. All groups must follow the fire regulations in effect at the time they are occupying the camp premises. Fires are allowed only in designated areas with the permission of the camp manager.
4. The renter will be required to provide insurance for both medical and personal property. The camp does not provide insurance for renters. Proof of insurance shall be in the camp board's possession when the deposit is made. Private family groups, i.e. reunions, are exempt from providing proof of insurance.
5. The renter shall be responsible for providing his or her own medical personnel and supplies. The camp does not provide a nurse for renters.
6. All trash will be deposited by the renter in the receptacles provided by the camp. Trash bags will be provided. The renter will provide all other supplies.
7. Fire arms or hunting is not allowed on the property.
8. Smoking is not allowed on the premises.
9. No meals will be provided unless noted in this agreement.
10. Linens are not furnished. Kitchen linens will be provided. Mattress covers are not to be removed from mattresses and mattresses are not to be removed from the bunks or the dorms.
11. Washing machine is for washing kitchen linen only.
12. Pets must be on a leash at all times and are not allowed in buildings. Renter is responsible for cleanup around the campus area.
13. Use of Summit Lake shall conform with the state of Colorado and/or lake regulations.
